INFORMATION ABOUT THE MANDATORY RESIDENCE MEAL PLAN FOR THE 2025-2026 SCHOOL YEAR

Kingston Campus



- A mandatory amount of \$2564.00 will be collected by the residence when you pay your residence fees. An amount of \$1182.00 + \$100 Flex will be allocated per semester. It includes the 13% Harmonized Sales Tax.
- This meal plan of \$2564.00 (\$1182.00 + \$100 Flex per semester) meal plan meets the Canada Revenue Agency criteria for tax free meal plans and therefore HST is not charged. This means the \$1182.00 meal plan provides a food value of the full \$1182.00.
- Flex dollars: \$100 to be used exclusively at St. Larry's Pub
- Once fees are received at the residence the money will be sent to Food Services to be put on a meal plan account (your student card).
- OSAP deferrals will not have any money on your account until the residence fees are paid and received in full.
- The meal plan is set up as a declining balance. The funds will be accessible by using your student card.
- The money on the meal plan is not meant to be the only source of food, it is a supplement for meal requirements.
- If a student goes home on weekends this allows for more to be spent during the week.
- **These funds are only available until they expire on April 30, 2026**
- If the student card is lost or misplaced the student must come to Food Service Office immediately to avoid theft or misuse of meal funds. The card will be canceled and a temporary card is issued until the lost card is found or replaced.
- All the money on the account transfers from 1st semester to 2nd semester but you are required to pay the \$1182.00 for your 2nd semester regardless of the balance still on your card.
- Should the student require additional funds over and above the mandatory, you can go directly to the Food Services Office to add more funds, pay at the front desk of the residence or use our online top-up site (scan QR code on previous page).
- Any student experiencing difficulty using their meal plan or requires assistance should visit the Food Service Office to make an appointment with the Operations Manager and Executive Chef.
