Eligible for Transfer Credit or Course Exemptions?

Transfer credits or course exemptions may be awarded to a student based on prior education and in recognition that the course requirement is waived through academic assessment and testing or assessment on prior academic achievements. If you wish to be considered for some transfer credits or course exemptions you will need an assessment of all your international school records including transcripts, diplomas, degrees, etc. to provide us with the Canadian Equivalency.

You can obtain this assessment yourself through these two options:

- Provide the College with an assessment from ICAS International Credential Assessment Service of Canada. You will require, at a minimum, the Secondary School Comprehensive assessment which provides details of your secondary school grades and courses. The fee for this assessment is CAD\$130.00. The fee for a Postsecondary Comprehensive Report is \$200.
- Provide the College with a post-secondary assessment from WES World Education Services. The fee for this assessment is CAD\$210.00-245.00 (depending on your package choice). Please see www.wes.org/ca for further information on how to order an assessment.
