

The President's List Award recognizes graduates who achieve academic excellence, participate in campus and community activities, and represent the college in conjunction with our core values: **Students First, Teamwork, Innovation, and Integrity.**

Eligibility

Eligibility is based on academic excellence along with participation and interest in activities and groups involving leadership, citizenship, and community service.

To be eligible for this award, students must satisfy all of the following requirements:

- Successful completion of all requirements of their program of study;
- Graduate with distinction; (see Academic Policy 8.7);
- Represent the SLC student community in conjunction with the Student Code of Conduct (see Academic Policy 16.0);
- Provide valuable and distinguished service to the college community via participation and involvement in any of activities or groups listed below:
 - Athletics
 - Intramural activities
 - Campus Club involvement
 - Student Union Association participation
 - Program or Departmental activities
 - Campus Committee involvement
 - Academic Recognition
 - Special Events/Activities
 - Volunteer Efforts and/or Community Activities
- Completion of the Nomination Form (Parts A and B).

Students who receive this prestigious award, and who have completed their program of study, are honoured during their Convocation ceremony. Winners will also receive a letter of support from the President's Office to aid in the continuation of their academic or career endeavors.

Students enrolled in a program that continues beyond their scheduled convocation date are still eligible to apply for the President's List Award. In these cases, President's List winners may choose to receive their award by mail or during a future convocation ceremony, following completion of all program requirements.

Nomination Procedure and Next Steps

1. Step One – Complete the nomination form.

The nomination package consists of the nomination form (Part A) and written submission (Part B). The written submission should include descriptions as to how you represent the college's core values as well as a brief summary of your involvement in the activities mentioned above.

2. Step Two – Faculty Nomination.

Once completed, your nomination form needs to be supported, or seconded by a faculty member. Seconders can include Professors, Program Coordinators, Associate Deans, Deans and campus Deans. Students must obtain permission from the seconder to list their name on the nomination form.

3. Step Three – Submit your nomination form to the President's Office.
