PURPOSE

This policy is intended to meet the requirements of the *Integrated Accessibility Standards, Ontario Regulation 191/11* set forth under the *Accessibility for Ontarians With Disabilities Act, 2005*. This policy applies to the provision of accessible services for people with disabilities.

SCOPE

This policy shall apply to every employee of St. Lawrence College.

DEFINITIONS

Word/Term	Definition
Accessible Formats	Include but not limited to large print, recorded audio and electronic formats, braille and other formats usable by persons with disabilities
Communication Supports	Include but not limited to captioning, alternative and augmentative communication supports, plain language, sign language and other supports that facilitate effective communications

Conversion Ready	An electronic or digital format that facilitates conversion into an alternate format
Educator	Is an employee who is involved in a program or course design, delivery and instruction
Information	Includes data, facts and knowledge that exists in any format, including text, audio, digital or images, and conveys meaning
Kiosk	An interactive electronic terminal, including a point-of-sale device, for public use that allows users to access one or more services or products
Performance Management	Activities related to assessing and improving employee performance, productivity and effectiveness with the goal of facilitating employee success
Redeployment	The reassignment of employees to other departments or jobs within the organization as an alternative to layoff, when a particular job or department has been eliminated by the organization

Procuring and Acquiring Goods and services or Facilities:</p> <p>2.1 The College will incorporate accessibility criteria and features when procuring or acquiring goods, services or facilities.</p> <p>2.2 When impractical to do so a letter outlining why this is not possible will be provided.</p>	<p>Senior Vice President, Corporate Services & Chief Financial Officer</p>
<p>3. Training</p> <p>3.1 The College will provide training for its employees and volunteers regarding the IASR which must also include training on the Ontario Human Rights Code. Training will be provided for all employees who are responsible for developing St. Lawrence's policies, and all other persons who provide goods, services or facilities on behalf of the College. 7. 7.1	<p>7. Documented Individual Accommodation Plans</p> <p>7.1 Human Resources will develop and implement processes for documenting individual accommodation plans for employees with disabilities. The process for the development of these accommodation plans should include specific elements, including:</p> <ul style="list-style-type: none"> • The ways in which the employee can participate in the development plan; • The means by which the employee is assessed on an individual basis; • The ways an employee can request an evaluation by an outside medical expert, or other experts (at the employer's expense) to determine if accommodation can be achieved, or how it can be achieved; • The steps taken to protect the privacy of the employee's personal information; • The frequency with which the individual accommodation plan should be reviewed or updated determined, and how it should be done; • The means of providing the accommodation plan in an accessible format, based on the employee's accessibility needs.
