- 3. Update from Equity Census working group 2:15 p.m. 3:15 p.m.
 - a. Breakout session discussion
 - Ekta broke the taskforce into subgroups to provide feedback on the first draft of the equity Census. Each group provided feedback.
 - Ining, Chris, Wendy privacy (anonymous), new intake students, who will the survey include, goal and goal setting, confidential, Q7 not about citizenship, repeat Q8 in the FAQ, glossary of terms.
 - Joel, Jessica, Shirley removing the word Aboriginal, translation of other languages, not the whole survey but sections, Q20 + Q21 representing how they feel represented and how they see themselves.
 - Alejandra, Robert, Owais Q11 chronic health condition, working with Caryn Langstaff to ensure we have the correct info, want to share any discrimination, are you a caregiver or a family support role, have another option with a textbook for each question, Q11 using the word experience, rather than conditions, Q12 Social economic question.
 - Sara, Julie, Shanika have the purpose in the first paragraph, making sure this survey is anonymous or confidential, shorter version in an email and the longer section on the census survey, clear definition beside the question to explain the terms (Q8), breaking down each status of employees and students, add a question about identify 1,2,3,4, language that they speak, add a questions about asking where they were born and how long they have been in Canada, mix up the format of the answers.
 - Richard, Raven, Krista the preamble add a statement about regardless of their background, so they feel like they are adding value to this survey, Q11 add these to the answers mood disorders, anxiety disorders, adding resources at the end of the survey, short the language at the start, updates about the taskforce.
 - Robert wants to know how we can make this real for someone. How can we connect with staff and students and create a powerful vision for our messaging.
 - Julie suggested adding quotes, videos, communication from students and staff and Glenn asking for help. Having taskforce members talk about this vision less than 30 seconds.
 - Chris wants to ensure that this survey is open longer to ensure that everyone has an opportunity to fill it out.
