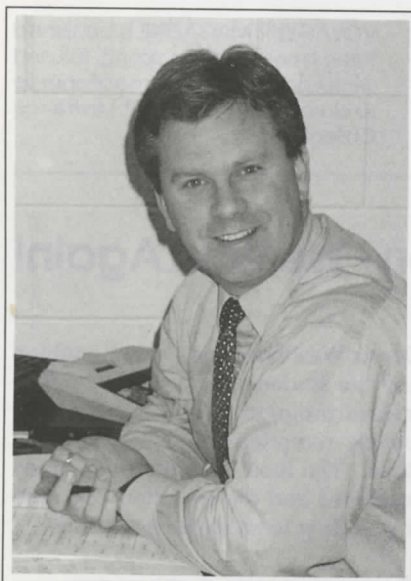

Practising the three R's



When Joe Davis was a student at St. Lawrence College the three R's meant something very different to him then than they do today.

As General Manager for the Kingston Area Recycling Corporation, Joe Davis (Business Administration - Finance/81-Kingston) heads up the area's largest recycling program. Reduce, reuse and recycling has become a way of life in Canada and Joe lives it every day.

Joe began his work in the field of waste recycling three years ago and was charged with implementing a waste reduction program for the Kingston area. Today he supervises a staff of 17 people who oversee the collection and processing of recyclables.

"One aspect of my work here is to look for markets for our recycled goods," explains Joe. "We generate over \$400,000 in revenues from the sale of various items which helps to offset the cost of our operation."

The recycling program in the Kingston area has been so successful that plans have recently been approved for a \$1 million expansion to the Corporation's facility in the north end of Kingston.

"With this expansion, we expect to double the number of products accepted for recycling," Joe says.

It was in the late 1970s that Joe Davis left a career in sales to return to school at St. Lawrence and study Business Finance. But studies were not the only thing on Joe's mind. From the start, Joe became involved with the Student Government at St. Lawrence, initially as a first year rep and then as President of the Student's Union from 1979 to 1981.

"I recall it was a busy time for me," says Joe. "I was married, working part-time at Kingston City Hall, and studying full time over and above my role as President of the Student Government."

Today, with an expanding operation at the Kingston Area Recycling Corporation, four busy children at home, projects at his church and a treasures' role with a local gymnastics club, Joe is still very involved at work, home and in the community.

We are all given the same number of hours in a day and yet some people, people like Joe Davis, seem to make the most of them.

Bill and Susan Jansman

Bill and Susan Jansman are reminded of their college experience every day.

Both graduates of the Brockville campus, Bill and Susan met over 20 years ago during a St. Lawrence winter carnival pub rally. Today they are husband and wife, business partners and best friends.

Bill completed his studies in Business Administration program in 1975 and began a banking career with the Royal Bank. After a couple of years he returned to run the family farm in Spencerville.

Together with Susan, a 1976 graduate of the Nursing program, the couple married in 1978 and in 1980, they purchased the family farm where they expected to live and work the rest of their lives.

"We were quite happy on the farm," explains Bill. "My business background from the College was very broad and this really helped with the business side of the operation. But farming is a tough business and to help out with additional income, Susan began running a marketing business out of the house."

What started out as backup to the farm operation became a major source of revenue.

"When it appeared the General Agreement on Tariffs and Trade, (GATT) would eliminate the milk marketing boards in Canada and drastically effect our dairy operation, we decided to sell the farm and try to make a go of our marketing business," says Bill.

"We knew that owning our own business was what we wanted," explains Susan. But the dairy business was very uncertain so we started our own interactive distribution business through J.L. Reid Co. of North Carolina. What started as a back up income has become much more. This will be our future and our children's future."

"The marketing business has allowed us to work and travel together as a family. We now act as consultants, helping other people to set up home based businesses. Farming gave us a wonderful life but our new business is giving us a life style we could never have had on the farm."

It is a long way from Cornwall to the Yukon Territories

It is a long way from Cornwall to the Yukon Territories but the north is where Glenn Gabrielson calls home.

Glenn is a recent graduate from the Appraisal and Assessment program. A native of Saskatchewan, Glenn lived in the Yukon from 1982 to 1988.

"After my wife was transferred with her work to Cornwall, I looked at the opportunity to upgrade my skills and enrolled at the college," says Glenn. "I was 40 years old when I graduated. Things were pretty tight financially but I had a lot of support from my family."

"The program was really great for me," explains Glenn. "I had a construction worker background and a lot of my knowledge was transferable."

Glenn was very successful with his studies at the College and was recognized with several awards at his graduation ceremony last year.

As a Property Assessor with the Yukon Government, Glenn has responsibility for new property assessment for tax purposes. His territory is sparsely populated but he claims the work is very interesting. From assessing values on vacant land to examining various mining claims, the work is varied.

"The territory has 33,000 residents and 23,000 of those live in Whitehorse," says Glenn.

Glenn and his wife recently purchased a new home and together with their two children, plan to stay in the north.

"There is plenty to do here," he says. "This past winter I have been out skiing, both cross country and downhill. And in the summer the days are very long."

Says Glenn, "There is a big future for the Yukon in development and tourism."

GOLD FOR ARLEEN!

Arleen arrived at the Regional School of Nursing on April 1, 1968. She began her teaching career in Nursing and soon emerged as team leader and coordinator under the direction of Mrs. Tatiana Labekovski. Her liaison work with the local hospitals including Winchester and Alexandria was instrumental in moving the hospital-based Schools of Nursing into the educational arena.

In May 1973, the Regional School of Nursing became part of St. LAWRENCE COLLEGE SAINT-LAURENT. In order to maximize the benefit of the new building, Arleen served as a pioneer in designing and spearheading the Individualized Nursing Program. This new program required the commitment and efforts of all faculty. Arleen and Phil Christenson orchestrated the rewriting of all nursing curriculum and testing material in a six month period. Arleen has always had a keen interest and ability with curriculum design.

As was anticipated, Arleen replaced Tatiana Labekovski as Chair of Health Sciences in 1977. As a leader and team builder Arleen was always dedicated and hard working. She very seldom missed work due to weather or health conditions. In fact, if she was absent, the staff always said: "She must be really sick or the road from Alexandria must be blocked."

Having done an excellent job at leading the Health Science Department, she was put to the test to see if her skills were portable to Technology and Trades in September 1983. During this year, outside her main discipline, Arleen shone as an educator and team builder. She

knew how to deal with people regardless of the discipline. She also became a role model for other budding female management interns who aspired to be recognized as an authentic manager on a team which was predominantly male.

In September 1986, she was in charge of the enlarged department of Health Sciences and Applied Arts. Having managed most of the campus, she was a frequent acting-principal while the principal Bert Martin was away negotiating collective agreements.

In January 1990, Arleen became the Principal of the Cornwall Campus. It was a natural progression for her career. A small step for Arleen but a big step for Employment Equity and the presence of women at the senior management level.

As the College reorganized several times from 1992 to 1993, Arleen moved from Principal of the Cornwall campus to Principal, Educational Programs and Services. Many of these changes were greeted with calm and acceptance because the staff knew that Arleen would be fair and would see to it that human concerns would be considered in whatever changes were needed. Arleen made hard decisions such as moving the Trades department to Moulinette Hall with as much input as possible from the staff. She spent some time working with the trades faculty during the financial crunch of 1991. It was shocking at first for staff and students to be requesting help from the Principal in the TRAC centre. Her style and warmth made her one of the group in a short time.

Having spent most of her career at the level of design and administration it was appropriate that Arleen became the Principal, Academic Programs. She was then in charge of all academic activity for the college starting in January 1993.

In June 1993, Arleen became the Vice President, Academic Programs and Senior Academic Officer for the College. During this time it became obvious that we were headed for major changes; a new president, total quality management and a deficit budget. Arleen embraced the challenge and under the direction of Dan Corbett, the new president, Arleen was empowered to match activity to actual dollars of income. This task of rationalizing and revitalizing our many processes at the College called for clear vision, shifting paradigms and strategic planning. Arleen was ready for the task and open to looking at old problems in new ways. Her leadership has allowed us to create the future needed after the year 2000.

Arleen will be missed after her leaving on April 15th, 1994, but no one could begrudge Arleen the opportunity to spend more time with her husband Roger and their many children and grandchildren.

The staff of St. Lawrence College thanks Arleen Cain Roy for all her dedication and hard work while managing at the College. May you enjoy health and happiness and look back on your 26 years at St. Lawrence with pride and satisfaction. You earned the Gold Medal. Bravo!

St. Lawrence College was no exception.

It seemed there was an unlimited supply of money from the Province and an unlimited supply of students from our communities.

Where was the motivation to become efficient and customer-focused?

The results speak for themselves. For the past five years, full-time enrolment growth has not kept pace with the system average. Part-time enrolment has been clobbered, primarily because of a migration of students to the more nimble and flexible private colleges springing up across all of our communities. Even our training business hasn't kept pace with the high rate of growth in that sector. In the past, the Province demanded that the lion's share of the training dollars flow through the colleges. Clients looking for training had very little choice. Once again, there was no motivation for the college to be responsive to the market. When forced to compete for our fair share, we were like a fish out of water.

It should, therefore, have come as no surprise that these results would necessarily lead to budget problems. We were losing students to other colleges and to private trainers, in addition to losing funding from the Province in absolute terms.

Simply put, we had an organization which did not match up at all well with the changes in the environment. The marketplace was changing rapidly, yet we were constrained by a large, cumbersome bureaucracy. Even when we finally did take action, we did things three times!

It was a scenario not much different from the one that had been confronting private sector organizations for the last decade. New competitors with a strong customer focus and the ability to leverage technology were making dramatic gains in market share. The old bureaucracies were forced to either learn from "upstarts" like Sony and Toyota, or perish. Many, like Xerox or Motorola, used the opportunity to become world leaders in their chosen fields. Others... did not.

Redefining

In St. Lawrence's case, the choice was very simple: trust to the generosity of the government and the taxpayers of Ontario, or take the initiative to put together an organization better able to respond to the realities of the new marketplace. St. Lawrence chose the latter course.

In a four-point plan presented to the Board of Governors at their February/94 meeting, management outlined its strategy to redefine the College.

1 Implement Total Quality Management

The tenets of Total Quality Management have revolutionized the way North America does business. Data-driven, customer-focused teams now characterize our most successful organizations. St. Lawrence has become a leader among Ontario's colleges in implementation of TQ. Where many colleges are talking about it and doing some training in TQ, St. Lawrence is actually practising what it preaches. The College uses the techniques of TQ to manage its operation. In addition, what will clearly set St. Lawrence apart is the incorporation of the tools of TQ in our academic programs beginning Fall '94. It's what employers want.

2 Develop New Programs

In the private sector case, those organizations which best match their product offerings to the needs of the marketplace are those that win the battle for market share. The most successful organizations are continually refining their offerings to respond to changes in demand. The public sector case is no different.

At St. Lawrence, we are actively developing new programs which build on the strengths of our campuses, our people, and our commitment to technology. We expect to make application shortly to the Ministry of Education and Training for new programs to begin in the 1995-96 academic year.

3 Consolidate Current Programs

Market-driven companies also know they can't be all things to all people. Organizational focus is essential for sustainable long-term growth. Therefore, St. Lawrence will move some programs and discontinue others effective September '94, to begin the process of giving each campus a focus.

In response to community need, the Cornwall campus will focus on the convergence of business and technology. The innovative Business Technology Information/Communication Systems program will move to Cornwall in September to support this focus. It will be

complemented by an already strong core of technology programs, including the highly respected Marine Engineering program. Technology offerings will also be supported by a new wing with state-of-the-art lab facilities.

In Brockville, where there are distinct natural advantages in tourism, St. Lawrence will grow its successful 1000 Islands Summer School of the Arts and its Hotel/Restaurant Administration program. The city also has a strong social services flavour, so the popular DSW and CYW programs will continue to be developed. The College's Law and Security Administration programming will also be consolidated in Brockville.

Kingston's economy is diverse and stable, so St. Lawrence's programming will respond accordingly. However, the College is taking steps in the technology area, in particular, to develop a centre of excellence. St. Lawrence is consolidating all Kingston technology programming in the Leeds Building. When matching funding can be secured from the private sector, St. Lawrence will use its share of the recently-announced infrastructure grant to renovate the building and produce a technology facility that is among the best in Ontario.

Each campus will have a particular area of strength which will allow it to draw students from beyond the immediate area. At the same time, each campus will continue to offer a strong core of programming through the Schools of Applied Arts, Health Sciences, Human Studies, Business, Technology and Trades, and Continuing Education, as well as through its Community Learning Centres and its Centre for Business and Industry Services. St. Lawrence will continue to be a full-service, regional college.

4 Streamline Administration

An organization which responds to the realities of the new marketplace is one that is lean and focused, driven by the initiative of empowered teams rather than layers of supervisors. It commits the maximum amount of resources to delivering the best products and services, rather than perpetuating arcane, bureaucratic systems. St. Lawrence will be that kind of organization.

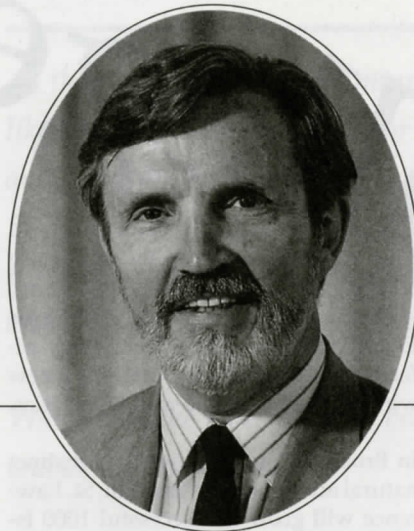
The College will continuously improve its administration/academic cost ratio. In the 1993-94 budget year, that ratio stood at 67:33. For the budget year 1994-95, it is forecast at 71:29 and the goal is to move to 75:25. In other words, St. Lawrence will spend more money in relative terms on the classroom activities than it will on administrative services and support.

This change will not be accomplished without a very high price. To balance the 1994-95 budget, over 90 full-time staff will leave the College. For an organization with just over 600 employees, it's a radical change.

It's never easy when people lose their jobs, for those involved or for those remaining with the organization. However, when the restructuring is complete, St. Lawrence will have a lean organization able to respond more quickly to changes in the environment.

With the creation of a new customer-focused Centre for Business and Industry Services, it will be less reliant on government funding and better able to call its own shots.

The new St. Lawrence will be well-poised for stable, focused growth. Within the region, St. Lawrence will assert its position as a leader in quality education and training. Across the province, it will be recognized as Ontario's Quality College. The future looks very promising.



Former Principal of Kingston Campus Named New President of Eastern Arctic College

In 1999, the North West Territories is splitting into two territories - one, still to be named, in the West and Nunavut ("Our Land") in the East. Currently, Arctic College has six campuses scattered throughout the North West Territories. Three of those existing campuses will be the basis for the new Eastern Arctic College - one campus is located in the Kitikmeot Region, north of Edmonton, one in Keewatin, north of Winnipeg, and one on Baffin Island (three hours north of Montreal by jet). Greg Welch, former Principal of Kingston Campus, accepted the position of President of the new College to serve the Eastern Arctic.

During the transition period, Greg's role (effective November 1, 1993) is Vice-President, Eastern Arctic Operations of Arctic College. The new College, yet to be named, is scheduled to open July 1, 1994. It spans three time zones and goes as far North as the Pole.

Nunavut will be a Territory governed by the resident Northern people, 80% of whom are Inuit. Accordingly, there is a great emphasis on education and job retraining in preparation for 1999. Several mines, including diamond mines, are expected to open in the near future. The plan is to retrain the people who live in the north, rather than bringing in people from the south. The Inuit will need to combine the best of their traditional ways with modern technology to develop the Territory successfully. They have problems, but they also have lots of potential to make it work.

Greg says that living in the Arctic is like going to another country without leaving Canada. He sees parallels to China and St. Lucia in terms of differences in culture. What is life like in the north for Greg? He has an apartment in Iqaluit, but says he travels almost half of the time. All travel is done by plane, as

there are only 21 kilometres of paved road in the Eastern Arctic. He can purchase a wide variety of goods in town, almost anything he wants. He can also purchase caribou, musk ox and arctic char (which he reports are all very delicious) which cost about the same as beef. Wilderness is only a few steps from town. Caribou roam the area by the thousands, some coming to the very edge of town. There are large parks close by and Greg says there is spectacular wilderness scenery with great natural grandeur to be found. And yes, it is cold, but quite bearable if you wear the right clothing!

His friends at St. Lawrence wish him all the best in this exciting new position.

Colleges Announce Economic Development Network

Gary Polonsky, Chair, Council of Presidents, is pleased to announce the establishment of CON-NET, the Colleges of Ontario Network for Economic Development and Training, to advance development in Ontario.

CON-NET will enable Colleges to expand their role in community economic development, through the provision of province-wide education and training agreements with organizations in both private and public sectors. Through the network, College system partnerships will be developed with MET, OTAB, universities and other College system partners.

CON-NET will provide a single point of contact with the Ontario College system for provincial training initiatives to be developed and delivered under contract by the Colleges.

The leadership for the development and implementation of this initiative will be provided by Keith McIntyre, President of Mohawk College. Keith will be assisted by the Task Force on Economic Development, chaired by St. Lawrence College President *Dan Corbett* and by Joan Homer, Executive Director of ACCATO.

Through CON-NET's computerised system head-quartered in the offices of ACCATO in Toronto, the Colleges will be linked electronically, sharing information about existing seminars, courses and programs available in Ontario. With the expansion of these offerings across the province, many more organizations will be able to access college-level education and training for their employees with provincial standards of accreditation.



St. Lawrence continues its International Tradition

During the reorganization of the College last summer, a new department was created to provide a clear focus for our international activities. The Institutional Development Department has an experienced administrator, *Alice Welsh*, as Director, and two faculty-level staff, *Al Parkin* in Kingston and *Joe Jordan* in Brockville acting as Program Administrators. All are equally committed to furthering the successful record St. Lawrence has established in international education activities.

The early focus of this team has been to negotiate a major project proposal through to its acceptance by an external funding agency. This goal came a step closer to reality last November when they conducted a Study Mission to Hungary at the request and with the financial support of Canada's Department of Foreign Affairs. At stake in this project is the creation of a Twinning Project with Szechenyi Istvan College in Gyor, Hungary. Through this project, St. Lawrence would establish its Legal Assistant Program (offered in Kingston for the last 20 years) and create an opportunity for several interested faculty to work in this exciting environment.

Due to the nature of this project, John Gerretsen, a Kingston lawyer, was engaged as a consultant for this project.

Among the countries of Central and Eastern Europe, Hungary is widely considered to have advanced the furthest toward a successful free-enterprise system. The evidence of this was widely apparent to our staff, both in the level of sophistication displayed in negotiations and in the entrepreneurial spirit with which they were conducted.

Szechenyi Istvan College and the city of Gyor are no strangers to St. Lawrence College faculty. Three have already spent varying lengths of time there as teachers of English as a Second Language. Both the school and the city are attractive locations. This Legal Assistant Project expands our participation as we will assist our Hungarian colleagues to establish the curricula, participate in the Program's marketing and placement activities and supply opportunities for international teaching assignments to as many as 18 faculty throughout the life of the contract.

As presented to the Department of Foreign Affairs in January, 1994, the project will run from this September until the Spring of 1997. By that time, two classes will have graduated and the process of ongoing course and placement evaluations will be established. Assurance of quality delivery and materials is important to St. Lawrence College, for this project will offer its Hungarian graduates a bilingual diploma presented jointly by Szechenyi Istvan College and St. Lawrence College.

There is real excitement about this project within the Department. The success of this proposal marks the expansion of St. Lawrence's participation in this highly competitive field of international project work. Its implementation also fulfils the commitment our President, *Dan Corbett*, has made to developing a concerted strategy in this area. Participation by our individual faculty will also provide an excellent vehicle for professional development in an international setting. Given the increasing importance of international literacy and relations to every institution, this is a strategy which promises long term benefits to our academic

CSAC

College Standards and Accreditation Council

Following the final report of VISION 2000, the government had given final approval to the creation of the College Standards and Accreditation Council (CSAC).

Terms of reference have been established and CSAC will:

- define credentials for, set standards for and accredit publicly funded college programs;
- develop for each program a system-wide program standards document which will specify learning outcomes for generic skills and program specific vocation skills, and any specific admission requirements;
- define general education goals, a framework of content areas and broad objectives, and required programs accredited by CSAC included a defined amount of general education. The responsibility for defining specific learning outcomes in general education will rest with those in the colleges developing general education curricula;

- oversee system-wide program review. Each program will be reviewed regularly to determine 1) the extent to which program outcomes which have been established have been achieved by students and 2) the appropriateness of program outcomes. Following the system-wide review of a program, the CoR, through CSAC, will determine whether the program will continue to be accredited at a college and any conditions which might apply. The accreditation status of the program will be publicly reported.

Reports have been submitted from nine pilot projects in provincial standards development to provide the CSAC Board with program outcomes, as well as processes used to develop the outcomes. An additional six new pilot projects have been approved in provincial standards development, including Interior Design, Ambulance and Emergency Care, Business/Business Administration - Accounting, Development Services Worker, Gerontology post diploma and post certificate and Travail Social/Social Service Worker.

The steering committee for each project will include half internal and half external members. Faculty and administrative staff from the college system, as well as labour, business, community groups and professional associations should all be represented. It is expected that outcomes will be developed in both official languages and final reports should be submitted in 1994.

Additional pilot projects are under way for General Education, Standards implementation in Early Childhood Education, Program review in Nursing and Nursing Assistance programs, and Human Resource Development needs related to CSAC (Phase I).

St. Lawrence is represented on the CSAC board by *Dr. Peter Jarrett*, member of our College Board and former Chair of the Board of Governors.

Tune in to Canadian Learning Television

St. Lawrence was recently featured in an application to the Canadian Radio-Television and Telecommunications Commission (CRTC) for a licence for a specialty service channel delivering educational programming to Canadians via satellite to cable. St. Lawrence College is among the initial academic institutions that have indicated support for a privately owned television channel, dedicated to adult education and lifelong learning.

Canadian Learning Television (CLT) is the only application of its kind to be submitted to the CRTC. It represents a breakthrough in Canadian broadcasting and education.

CLT is the creation of Dr. Ron Keast, who has more than 35 years experience as educator and broadcaster, currently as president and CEO of Vision TV; Moses Znaimer, founder and creative force of CITY-TV's (Much Music) integrated-environment, interactive television; and CHUM Ltd., one of Canada's premier communications media enterprises.

The philosophy of CLT is founded on a belief in lifelong learning as a prerequisite to employment in our rapidly changing society - a society affected by globalization, demographic factors, technological advances, and the shift to a knowledge and service-based economy. We believe that television is an exceptional learning tool, potentially equalizing Canadians' access to education by providing convenient, at-home learning opportunities.

CLT will achieve full potential through partnerships with a diverse group of service providers - education, skills training, broadcasting, cable, telecommunications, community groups, in-

dependent production, business interests, government and their agencies. Partnering will make possible accreditation of courses, the earning of diplomas, degrees and professional status - important to learners and employers alike. Partnering will also be the key to services to adult learners, including referral to prior learning assessment and facilitation of credit transfer.

• Programming Highlights:

Basic Adult Education

CLT will offer learning opportunities - some providing the opportunity to earn high school equivalency in basic skills for adults. Programs will address subjects such as literacy, numeracy, mathematics, communications, basic science, technology, English as a second language, interpersonal skills, analytical and problem solving skills, study skills, job search and career change opportunities.

Accreditation

CLT will offer a range of programs, presented as telecourses for credit in co-operation with universities, colleges and professional, trade and industry associations throughout Canada for earning degrees, diplomas and certificates.

Skills Training and Professional Development

Programs with support materials will be offered for members of sectorial, trade, professional and industrial associations. Some courses may be interactive or computer-mediated.

Enrichment and General Learning

CLT enrichment programming will include programs in all formats on subject areas of Canadian interest and concern. For example, series will address topics such as substance abuse, childbirth, parenting, gardening, and politics in Canada.

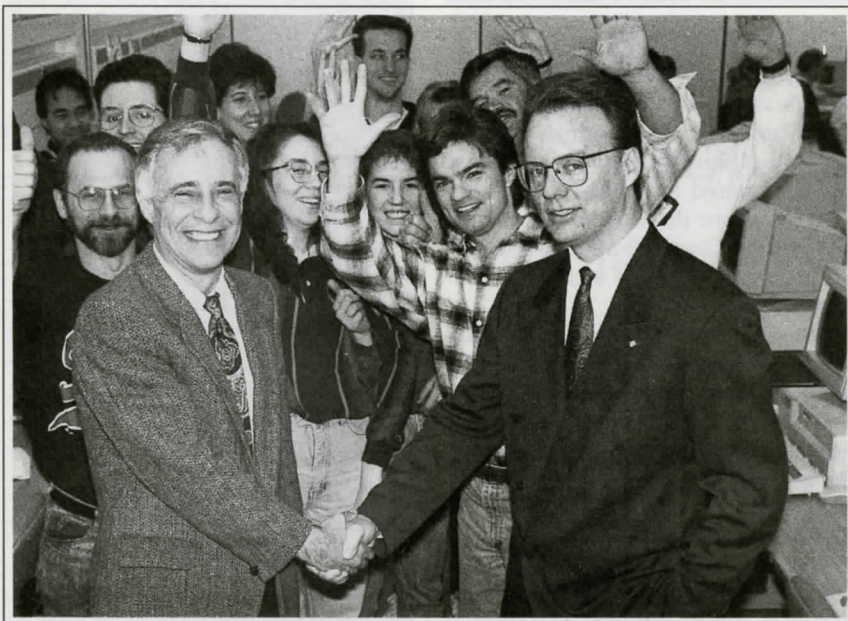
Service

CLT will provide individualized, interactive service to learners through telephone (and potentially on-line) resource centres. CLT will aim to connect Canadians with educational opportunities and services (such as agencies that access prior learning), as well as with job possibilities and prerequisite training. Viewers will also be able to order programming-related learning materials. At the heart of CLT's services will be a Learning and Job News program providing current information and issues to Canadians.

Stay Tuned

This unique opportunity could position our College firmly in the distance education business. St. Lawrence has written to the Secretary General of the CRTC directly stating our support for Canadian Learning Television, working in partnership with education to establish this new educational resource. We have requested an opportunity to appear at the CRTC hearing to outline our intention to develop an on-air series coupled with our credit correspondence studies in Early Childhood Education, School Age Day Care and Home Child Care Certificate programs.

A ruling by the CRTC is scheduled for the summer. If licensed, CLT could be on the air by January 1995.



Students welcome new software donated by Sterling Software

A Donation From Sterling Software

The Business Administration-Information Systems students have welcomed a recent donation of systems development software for their new computer lab. The "Developer" (from Sterling Software in Ottawa) is a Computer-Aided Systems Engineering (CASE) package which automates the process of analysing and documenting the business requirements of an information system. CASE tools are being used increasingly in Information Systems and we will be using this software in all areas of systems analysis and design to help train students for the current job market. Sterling is happy to be able to provide their products and to see our graduates entering the workforce with experience in the field.

Negotiations with Sterling Software of Ottawa came about as a result of a discussion at a recent Information Systems Advisory Committee meeting. Aware that St. Lawrence was looking for a CASE tool for the program, Howard Stavely of Queen's University Information Systems indicated that they had adopted Sterling's "Developer" and were very happy with it.

Implementation of the "Developer" has been very smooth in the lab and the I.S. faculty have now received a copy of Sterling's database software product, ZIM. If it can be incorporated into the curriculum, Sterling has promised to donate another class set. They have also offered a bursary to the student who makes the best use of the software, as long as the College will organize the competition.

Pilot Project For Minerva

St. Lawrence College agreed to work with the Ontario Committee of Project Minerva Canada in a pilot capacity to begin integrating health and safety into management education.

Project Minerva is an educational initiative that aims to help business and engineering graduates with a better understanding of health and safety issued in the workplace.

With Canadian businesses spending more than \$24 billion annually on occupational mishaps, safety is a bottom-line issue and one that represents a competitive advantage if managed properly. Unfortunately, managers are often ill-prepared to deal with the human suffering, tough laws, legal liabilities and enormous costs associated with workplace accidents.

In the fall, Queen's University hosted a Project Minerva symposium and workshop that was designed to bring stakeholders together to discuss best methods for incorporating health and safety concepts into business school curriculum.

So far, the College department heads have been provided with a general presentation by Minerva representatives. The Business programs have included U.S. Minerva case studies into their curricula and a guest lecturer has spoken to second year business students on loss control.

The Business Advisory Committee has approved a 12-hour component on loss control and managerial implications of health and safety to be added to the manufacturing course in the Business programs.

It is our hope that St. Larry's Lab can act in service to our students and to those who will employ our students as well. We therefore will be including a job posting area and a student resume area. In time we anticipate that St. Larry's Lab will be used as a conduit for distance and continuing education, truly bringing the information highway to your home.

The Bulletin Boards massaging system will provide an opportunity for productive interaction among many groups involved in technology. Through the various message categories, we will provide a coherent way for information and queries to be exchanged on specific topics with specific interest groups. Message areas have been provided for secondary schools, St. Lawrence Faculty and Staff, St. Lawrence College Students, St. Lawrence Alumni, Manufacturers, Sales Representatives, and the Instrument Society of America. Many more areas are anticipated and will be added as the interest for them is expressed.

St. Larry's Lab will be a user-driven centre of information. The uses to which the BBS will be put will be largely defined by the users of the BBS themselves. 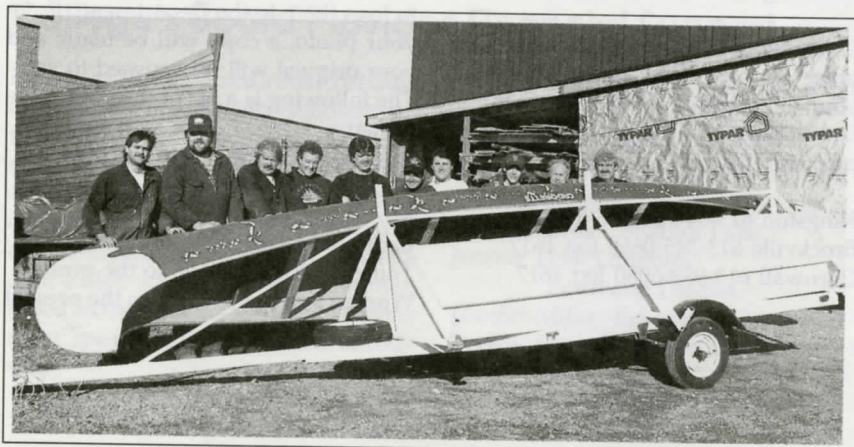
