

### Joel Roodman



t's 1980 and Joel Roodman sits edit-Ling a short promotional video for his Commercial Communications class assignment. At the time, no one says "Joel, you oughta be in pictures." And yet today, that's just where he is. Big time.

Born and raised in Ottawa, Joel spent two years at St. Lawrence College in Kingston studying Business, Commercial Communications in the late 1970's. After St. Lawrence, he was keen to get out and get to work.

"I didn't start out in films," explains Joel. "Right out of St. Lawrence I was selling photocopiers, door to door, in downtown Toronto."

From this base in Toronto however, Joel worked his foot in the door of the J. Walter Thompson Advertising Agency.

"That was an interesting story," says Joel. "I saw the ad for an account executive but they were looking for a university commerce grad with maybe an MBA."

Recognizing his college experience on paper might not get him the interview, a host of new opportunities. Joel drafted his resume out on the back of a pizza box. He then cut the box into several pieces and mailed it one slice at a time to the hiring manager. With one piece of the puzzle remaining to be sent, Joel contacted the Ad Agency were he was invited to come in to meet with them and, bring in the final slice. Seems they had been re-assembling Joel's resume on the hiring manager's desk all week. The job offer came soon after.

In 1983, Joel left the ad agency business to work in what was at the time, a new and emerging industry, Pay TV. First Choice had recently been granted a license to operate in Canada and Joel was to become Marketing Manager. A series of challenging positions in a number of film related organizations followed. But by this time, Joel had the bug. He was in the movie business.

One of his assignments in the late 1980's took him to New York where he spent two years working, commuting between Toronto and New York to establish an office for a Canadian company. And as the saying goes, "If you can make it there, you'll make it anywhere, New York, New York".

Joel set his sights on finding permanent work in New York. The luck of the lottery made it possible for him to acquire his green card and he began looking for a permanent position in the Big Apple.

In 1991, Joel left his executive position in Toronto to work as an assistant at MIRAMAX Films in New York City. It meant a huge cut in pay but also invited

For the next four years, Joel was Vice-President, Market Development for MIRAMAX Films where he was responsible for marketing, research, licensing, merchandising, promotions, international sales and new business development. MIRAMAX is the same company which has produced feature films such as Pulp Fiction; The Piano; The Crying Game; The Crow; Priest; Bullets Over Broadway; Strictly Ball-room; Tie Me Up, Tie Me Down; and Sex, Lies and Videotape.

"It is an incredibly exciting business," says Joel. "But it's also a high risk business and can be very stressful. You have to be good at setting priorities and you have to be able to turn negative situations into positive ones."

"Working with new ideas and meeting tons of new people is great. I love living in New York. You can feel the energy of the people but when you want to you can also feel very anonymous within the city. But, I still maintain my Canadian roots. Every Thursday during the fall and winter, I hike up to Harlem and play a great game of pick-up hockey with my friends."

Reflecting on his days at St. Lawrence, Joel remembers working with Tom Harpell in the fourth floor video studio to produce those memorable first efforts. Seems that Tom remembers them too!

"That's Joel Roodman," exclaims Tom when he sees a photo of the young executive. "Ihaven't seen him for years."

Tom then proceeds to shuffle through his library of video clips and, after dusting off an old Betamax machine, slides in the one marked Roodman, Comm Comm/80.

"Here's Joel now," says Tom. As the tape roles, he watches as Joel proceeds to demonstrate the features and benefits of his Louisville hockey stick to the Comm Comm class of 1980.

When the laughter subsides, Tom tells a few more "Joel" stories and jots down his address so he can send along a note.

"I doubt he's kept a copy of this one," says Tom. "I think I'll send along this masterpiece."

Last April, Joel left MIRAMAX to realize his dream of building his own film and television company, New York based Gotham Entertainment Group. The company has 15 feature film and television projects in various stages of development, including their first feature, Burnzy's Last Call, which premiered in May at the Cannes Film Festival in France.

Budgeted at just under \$400,000, Burnzey's Last Call stars Sam Gray ("Suspect"), James McCaffrey ("City of Stone"), David Johansen (A.K.A. Buster Poindexter, lead singer New York Dolls, "Married to the Mob"), Chris Noth (NBC's "Law & Order"), Carolyn McCormick ("Law & Order", "Enemy Mine"), Sherry Stringfield (NBC's "ER", "NYPD Blue"), Tony Todd ("The Crow", "Candyman"), Jamie Walters ("Beverly Hills 90210"), with a special International appearance by Supermodel Frederique.


Burnzey's Last Call features an all-original soundtrack written and performed for the film by artitsts Debbie Harry, Iggy Pop, The Smithereens, Buster Poindexter, Evan Dando, Lou Christie, Grahm Parker, and more.

With a full-time staff of 12 employees, Gotham expanded into distribution this past fall, and is presently releasing into secondary theatrical markets the provocative feature film KIDS throughout the United States and will be releasing the Isaac Mizrahi documentary UN-ZIPPED featuring Cindy Crawford, Kate Moss and Linda Evangelista in January. Plans for the new year also include a CD Rom publishing entity, as well as Gotham Interactive, specializing in the design of Internet web pages for the entertainment related companies. With six projects now in design for introduction in early 1996, the company's first site is up and running and located at www.sonicnet.com/kids.

Reflecting back on his days at St. Lawrence, Joel considers the experience the main stepping stone that provided the direction to where he is today, and where his goals are set for the future. But one thing about his experience still sometimes keeps him up at night. He asked this writer and all readers of this magazine for any help in locating a 'Geoff Oakes', an old roomate from Frontenac Street. "Yeah, that Oakes is still haunting me. What I would like to know is where the heck is the October 1980 rent cheque?"


### Robert Sicard



Ethyl alcohol (Ethanol) is produced using such farm crops as corn, wheat and barley and when blended with gasoline, produces an innovative fuel which has a renewable component and is more environmentally friendly than conventional fuels. UPI, which is jointly owned by Sunoco Inc. and Growmark Inc. blends six percent Ethanol with ninty four percent gasoline to create their "green gas".

From a retailing perspective, UPI supplies Ontario farmers and rural customers through thirty-one bulk petroleum storage plants, 104 gas bars & cardlocks, seventy-nine propane bulk storage & filler plants, and a fleet of tankers with units located throughout the province.

Although UPI's central office is located in Guelph, Ontario, Robert is no stranger to Eastern Ontario. Robert grew up in Alexandria. Following his completion of high school there, began his college studies on a part-time basis and his career on a full-time basis.



Robert worked with Cornwall Gravel and Grant Ready Mix full-time as a clerk during the day and undertook his studies with St. Lawrence at night school. In 1973, Robert joined BP Oil Limited, a company later acquired by Petro-Canada. Over the next 15 years, Robert held a number of positions with the two organizations.

"The travelling associated with my work made the continuation of studies difficult. I would never have graduated from the college if it hadn't been for some key faculty at the Cornwall campus", explains Robert. "While I was working out of town in Ottawa or Toronto, I would study at the local college and then apply for credit from St. Lawrence for my program in Manufacturing Management."

After six years of part time studies at four of Ontario's Community Colleges, Robert earned his diploma from St. Lawrence in Manufacturing Management. He then went on to earn additional credit from Humber College and an Executive MBA from the University of Toronto.

In 1988, Robert left Petro-Canada to take a senior position with McEwen Petro-leum here in Eastern Ontario. And later, with over 19 years experience in the petroleum industry, Robert was appointed President and CEO of UPI in 1992.

The company employs 135 full-time and 110 part-time staff across Ontario.

"The petroleum business is very competitive, says Robert. "There is a shrinking market for petroleum as automobiles and home heating systems become more efficient. UPI's niche is the the Ethanol which costs slightly more than conventional gasoline to produce but is considerably more environmentally friendly."

When he isn't concentrating on UPI's future, Robert spends time with his wife Kathy, son Blake and daughter Ashley.

The President and CEO of the growing company says, go forward everyday'. Since he began his studies at St. Lawrence it appears Robert has taken his own advice to heart.

# he College's Executive Committee presented a framework to advance the strategic plan, and deal with Ontario's new fiscal realities, at the December meeting of the Board of Governors. Some highlights are presented here.

Dan Corbett opened by saying the mandate of the colleges is clearly different from that of the universities in Ontario. One of our reasons for being is to provide our communities with access to higher-level skills demanded by today's economy: "There is an exploding marketplace for learning," Corbett said. "The issue is to help students develop a set of skills appropriate for the new economy.

The strategic plan discusses the use of campus task forces to develop differentiation strategies for the campuses in each community. Preliminary reports from the campus. For example, a justice training institute would seem to match the needs of the Kingston community; a manufacturing training program would match the needs of the Brockville community; and an entrepreneurial focus would match the needs of the Cornwall community.

# College's Strategic Plan Holds Despite Funding Cuts

Academic VP Jeanie Sawyer also discussed a number of other new programming ideas that are being explored: Pharmacy Technician (B,C,K), Health and Fitness Promotion(C), Automotive Technician(C), Civil Technician (K), Native Peacekeeping, Correctional Worker-Aboriginal, Hotel and Restaurant Management (K), and alternate delivery strategies for GAS. "Our goal is to continue to have quality programs that meet the needs of our communities, " she said.

Jeanie also said that "at this point, I am not recommending any programs for suspension or cancellation. The appropriate program mix will fall out of the campus task force efforts and the program review process. Programs that do not meet performance indicators, like an appropriate contribution margin, will have an opportunity over the coming weeks to restructure and bring their revenues and delivery costs in line.

Blayne Mackey, VP Administration, talked about two items. First, he discussed the framework to be used to develop cost reduction strategies on the Administration/Support Services side of the operation. He noted where the college would look for savings in the fixed, variable, and discretionary expense areas. He also went on to introduce the model for an early leaving plan for staff.

Dan Dexter talked about the steps the Centre for Business and Industry Services was taking to continue to increase its contribution to the college. "The mandate to decrease St.Lawrence's reliance on government funding has always been there," he said. "It's in the business plan, and it's in the college's strategic plan. The new fiscal situation in Ontario has simply changed our timetable. We have to move much more quickly. Things that we had planned to do next year we have to do now." The Executive Committee will be working within the framework to develop a concrete set of recommendations for the February meeting of the Board.

### CAMPUSES MUST BECOME SELF-SUFFICIENT, CORBETT SAYS

St.Lawrence College will maintain access to learning but all campuses will have to cover their own costs, President Dan Corbett tod the Board of Governors at the December meeting. Corbett told the Board that recently, the Kingston campus has generated enough of a contribution to cover shortfalls at Brockville and Cornwall. At the 1996/97 funding levels announced for Ontario's colleges, a strategy of subsidizing campuses in the smaller markets becomes impractical.


"We have listened to our communities," Corbett said, "and they clearly understand the impact the college has on life in the region. We will maintain access, but we must change the way we deliver education, and change the cost structures associated with operating a college, in order to meet the demands of the new fiscal environment."

Funding cuts of \$120 million for Ontario's colleges were announced as part of the Ontario government's Economic Statement two weeks ago. St.Lawrence's share of those cuts appears to be approximately \$6 million, though cuts to related organizations OTAB gave yet to be announced.

"We have a paradox," Corbett said. "We are in an information age where the programs and services of this college have never been more important in the development of our communities and the province. At the same time, we have an erosion of the traditional fund-

ing mechanisms on which employees and learners have to rely." According to the Association of Colleges of Applied Arts and Technology of Ontario (ACAATO), between 1986 and 1994, Ontario colleges accommodated 39% more students with 33% less funding. The grant per student peaked at \$5,344 in constant dollars in 1986, and had fallen to \$3,594 by 1994. With the 1997/97 cuts factored in, it is expected to fall to approximately \$2,953 per student.

St.Lawrence is enjoying a banner year in terms of enrollment. Growth in the number of first-year students was second-highest amount all Ontario colleges. Overall enrollment grew by 3.4% beating the college system average for the first time since 1988.



onstruction is underway on a new facility intended to serve both full-time Technology students and the College's Business and Industry clients. The facility will be housed within Grenville Hall on the Kingston Campus and be know as the Applied Technology Institute (ATI).

Phase I of the project will see a complete renovation of the former Student Centre which has recently relocated to Glengarry Hall. Funding for Phase I of the project, estimated at \$1 million has coming from the Canada/Ontario Infrastructure Program.

"This project illustrates the College's comittment to high-tech training at St. Lawrence", Dan Corbett, College President says. "We plan to build on four strong technology programs; Computer Technology, Measurement and Control, Microelectronics and Civil Environmental."

The ATI will operate in the spirit of partnership. Corporate partners have been invited to invest in the facility through contributions of computer equipment, software, and specialized instruments. These partners will have special access to the facility for their own training purposes as well as testing of technology still under development.

"We expect our partners will also use their participation in the ATI to 'showcase' new products to current and prospective customers," explains Corbett.

Full time students will have access to state of the art technology and will be able to quickly transfer their new skills and experiences to the workplace upon graduation.

Construction on Phase I of the ATI is expected to be completed later this winter.

Phases II and III, which involve the continued redevelopment of Leeds and Grenville Hall, will evolve over the next two years as funding becomes available.

# Canadian Designers' Cooperative together with St. Lawrence College

ward winning fashion designer, Carrie Whalen, has teamed up with Melanie Davison-Myers to develop a design house that may catapult Kingston to international recognition as a centre of excellence in design. Patterned after houses in France, New York and Toronto, The Canadian Designers' Cooperative (CDC) will incubate fresh artistic talent and launch careers in design related fields.

"The idea of a cooperative appealed to me," explains Whalen, "because designers working together would generate a creative atmosphere and provide a support network for the exchange of technical know-how. The shared facilities would also reduce operating costs for all of the businesses."

To prepare for her role as entrepreneur, Whalen completed "The Community nationally recognized design house -and for moving the cooperative from concept to reality.

"Both Carrie and I envision the CDC as a launch pad for successful careers in design," said Myers. "By creating a nurturing work environment, we aim to foster productivity and imagination."

To create a cooperative that embodied this progressive style, Whalen and Myers solicited recommendations from potential CDC users which were then integrated into the development process. In this manner, the CDC evolved in response to the actual needs of designers rather than perceived needs; a strategy expected to underlie the success of the project.

There is a symbiotic nature to the CDC where the success of one member is expected to generate greater opportunities for other members. In this way, designers who become established effectively carve a path for other CDC designers to follow. The result: a broader base for business networking, more industrial contacts, and an increased focus on the CDC as an incubator for design talent.

With the notice that Carrie Whalen has already received in the fashion industry, the path she carves for herself and for other CDC designers may just catapult Kingston into international recognition as a centre of excellence in design.

Make sure to pop by 12-1/2 Princess St. to the CDC's Boutique where you can view various lines from the designers. The boutique, which has been open since June is located in Kingston at the bottom of Princess St. between the Cornerstone and the Holiday Inn.



Acting as a large umbrella company, the CDC will house a number of smaller independent businesses. Designers, while striving to meet their individual entrepreneurial goals, will work together under one roof; sharing building space and equipment. There are a number of design businesses housed at the CDC including: Bev Heighway, Carrie Whalen, Davison-Myers, Lianne Cola and R.R. Moller Fashions.

Whalen conceived of the Cooperative while in Paris, France, where she was one of ten Canadians competing in The International Young Designers Competition, 1993. Placing first for Canada and fourth internationally, she returned to Kingston with the bolstered confidence to open her own business.

There were twelve categories in all, open to students from Canadian colleges and universities. Telefest is the largest student video competition in Canada.

The video had already captured awards at the Greg Awards and at the Barrel Awards. The alumni were honored at a speical awards ceremony in Toronto.



"The awards have been a tremendous boost to these students", explains Brian Murphy, Financial Aid Councillor at the campus.



### Class of 1970

June 24th, 1995 - together, again.

We have come from far and near to confront strangers. Strangers that are our yardstick, something with which to judge. To our surprise we former "teens and twenty-somethings" looked into each other's faces and see ourselves.

The wrinkled brows, the graying hair, the 'ponchy' body shapes and receding hairlines speak to us of our own passing years. We see more clearly how far we each had travelled.

Introductions are made in the sweltering heat at the gymnasium doorway. We are careful to give our full names to prevent each other's embarrassment...faint recollections... desperate to remember.

How tired we all looked. Where has that youth gone?

At first each remained remote, uncomfortable with the aging of our peers. But soon, it was our voices that brought us closer together.

A remembered delivery, that unique enunciation, a singular mannerism gradually brought each individual back for us. From the fall of 1967 to the spring graduation three years later those voices had echoed through the halls of our minds.

Her laugh,... I know it! His wit is unchanged. That's the way we were. The spirit of each of us had remained untouched by time. Singular personalities still shine through...intact... unscarred...alive!

I remember them now...ah...twenty-five years ago...What did we do with those years? They were spent building our



lives, developing our careers, finding ourselves and struggling with the offerings of daily life and love.

At first we ask each other, "What are you doing now?"

We answer as if we <u>are</u> our job. There is no time to explain the whole journey. The joys and disappointments, successes and failures are left out.

The knowledge, experiences, and maturity we acquired at St. Lawrence College coupled with our own distinct capabilities and goals makes for remarkably diversified careers and lives.

The class of 1970 includes in its membership, a crossing guard burnt out by two demanding careers; government middle management in Revenue Canada, the Department of Agriculture and Statistics Canada, a C.A. from an accounting firm, a trust company executive, a pharmaceutical salesman, a materials acquisition specialist, and a house dad that sells homes on the side. Others are marketing specialists, employment consultants and industrial fastener veterans.
